The candidate has clean passed record and has never committed any offence nor involved in the commission or omission of any offence, however, out of political vendetta two different FIR'S have been lodged against the candidate out of which one challan has been presented before JMIC Charari-Sharief under sections 341, 506 RPC, under FIR No 23/2019 titled as State through Police Station Charari-Sharief V/S Zahid Hussain Jan & Ors and another challan under section 353 of IPC, under FIR 114/2020 before JMIC Charari-Sharief titled as State through Police Station Charari-Sharief V/S Zahid Hussain Jan. in both the cases charge has been framed, statement of complainant/main witnesses stands recorded, separate applications for compounding the offences have also been filed by the complainants/ witnesses in both the cases. There is no material substance in both the cases and both cases are outcomes of political vendetta.
