He is a senior party worker and had edge over other individuals. The candidate has clean past record and has never committed any offence nor involved in the commission or omission of any offence However, the learned special Judge Anti-corruption Jammu, during the trial of final report bearing no.20/challan dated 02-09-2015 titled State V/s B.A. Dar &Anr. u/s 5(2), PC Act r/w 420, 468, 471, 120-B, RPC in FIR NO.36/2013 issued Notice to the candidate, vide order dated 24-05-2024. The order dated 24-05-2024 was challenged by the candidate before the Hon'ble high court of J&K & Ladakh at Jammu and the Hon'ble High court vide its order dated 03-
		06-2024 stayed the operation of order dated 24-05-2024. The said case has no substance and is outcome of political vendetta.
